The Confidential Print series, issued by the Foreign and Colonial Offices since c. 1820, originated out of a need for the Government to preserve all of the most important papers generated by the Foreign and Colonial Offices. Some of these are one-page letters or telegrams; others are large volumes or texts of treaties. It covers the Egyptian reforms of Muhammad Ali Pasha in the nineteenth century, the Middle East Conference of 1921, the Mandates for Palestine and Mesopotamia and the Suez Crisis in 1956, the partition of Palestine, post-Suez Western foreign policy and the Arab-Israeli conflict. All documents are fully text-searchable.
